

VILLAGE OF BELMONT
REGULAR BOARD MEETING MINUTES

A regular meeting by the Board of Trustees for the Village of Belmont was held on Wednesday, January 18, 2023 and called to order by Village President Brad Bockhop at 7:00 PM in the Community Building.

The Pledge of Allegiance was recited.

Present were Trustees Kay Austin, Kathy Riechers, Mark Pinch, Jason Brecker, Derek Riechers and Dennis Popp. Also present were Clerk-Treasurer, Julie Abing, Public Work's Director, Tony Kunz and Chief of Police, Kurt Malott.

Verification was given by Ms. Abing that the meeting had been properly noticed.

A motion was made by Brecker seconded by Popp to approve the agenda, minutes from the last board meeting, Clerk-Treasurer's financial report, and the lists of invoices for payment. Motion carried.

Citizen's Comments – There was no one present.

President Bockhop had nothing to report.

The monthly Police report was presented by Chief Malott.

Dan Dreessens of Delta 3 Engineering discussed the development of streets & installation of utilities for the 1st Addition of the Liberty Ridge Subdivision project. Village Board gave Delta 3 Engineering permission to proceed with a bid package for installation of the infrastructure.

A motion was made by Pinch seconded by Austin to adopt Resolution 2023-2 to change 2022 budget account allocations as presented. Roll call: all "aye". Motion carried.

A motion was made by Austin seconded by Popp to adopt Resolution 2023-1 to approve the 2022-2027 Lafayette County Hazard Mitigation Plan. Motion carried.

A motion was made by Brecker seconded by K. Riechers to approve the Civic Systems contract presented. Motion carried.

Mr. Kunz, Mr. Malott and Ms. Abing left the meeting.

At 7:40 PM, a motion was made by Brecker seconded by Austin to convene into closed session pursuant to WI Stat §19.85 (1)(c) for considering employment, promotion, compensation, and performance evaluation. Roll call: all "aye". Motion carried.

At 7:58 PM a motion was made by Austin seconded by Popp to reconvene into open session. Motion carried.

There was no action from the closed session.

At 8 PM a motion was made by K. Riechers and seconded by D. Riechers to adjourn the meeting. Motion carried.
